### Job Description

The ING London Internship Programme: A structured programme aimed at university students and recent graduates. The programme will offer first-hand experience of what a career at ING is like by giving you an opportunity to observe and get involved in the day to day running of the business. An internship at ING will allow you to explore your interests and develop your professional skills and capabilities.

### Job Responsibilities

- Handle CPRI requests and assist in negotiating and signing insurance policies.
- Manage deals from first enquiry to binding with brokers and deal teams.
- Organise ING Insurance Day sessions and other ad hoc presentations to insurers.
- Produce quarterly reporting and internal product presentations.
- Coordinate adequate support for the product from all functions within the bank (Legal, Risk, Tax, etc...).
- Support other CPRI colleagues and the portfolio manager in team projects.
- Assist in data quality and be conversant with all systems used in CPRI at ING.
- Always adhere to strict compliance procedures and Swiss banking secrecy policy.

### In addition

- Working with the rest of the interns to put together “meet the manager” sessions amongst the managers, networking events and product sessions;
- Actively participate in volunteering opportunities available through ING's charity partnership initiatives;
- Think of ideas for charity events for the London office and take them on and making them happen!

## Your Work Environment

You will be an integral part of an Amsterdam and London-based, 7-strong team in charge of Credit Insurance (CPRI) globally. The team responsible for coordinating the bank's efforts in insuring loans on a global basis. The responsibilities include handling many requests for insurance from various ING lending teams (all products and sectors) and liaising with our 2 brokers (and directly with some insurers).

The team head (responsible for the product globally) is currently based in Amsterdam with one colleague. The rest of the Team is based in London. Other Loan Distribution Group (LDG) colleagues are based in Asia and New York fulfil similar roles but part-time with the support of the central team in Europe.

CPRI has developed exponentially since the creation of this centre of excellence in LDG (the portfolio grew from EUR 500m in 2013 to EUR 18.7bn as at end 2024) and processes and controls have improved constantly (secondary limits, policy wordings, system, etc...). ING is a recognised buyer of insurance with a strong reputation for credit quality and variety of sectors.

CPRI is one of the ways of distributing risk in our loan portfolio along with loan sales (primary and secondary), securitisation and other portfolio management techniques.

## Career Potential

This role provides an excellent opportunity to gain an introduction to working within the department, with the potential to apply for permanent roles as available.
